Consider and discuss a request from Esther Morales, property owner, for a variance from the side yard setback requirement of fifteen (15) feet from the property line adjacent to the side street, as per the "R1" Residential One District that this property is located. The applicant is requesting a zero side yard setback for a carport to be placed on the property line of the side yard of their property located at 1509 30th Street Hondo, TX 78861. The legal description being, Pope Unit 3 Block 5 Lot 1, in Hondo, Medina County, Texas. In accordance with the Unified Development Code, Chapter 3, variance from the Unified Development Code, Chapter 3. 3.13 Variance. The Board of Adjustment shall have the power to authorize upon appeal in specific cases such variances from the terms of this ordinance as will not be contrary to the public interest where, owing to special conditions, a literal enforcement of the provisions of this ordinance would result in unnecessary hardship. A variance from the terms of this ordinance shall not be granted by the Board of Adjustment unless and until it is determined.
